Dear Chairman Cole and Ranking Member DeLauro:

I am requesting funding for a Multi-Modal Operations Complex (MDOC) at Beale Air Force Base (AFB) in fiscal year 2026. The entity to receive funding for this project is Beale Air Force Base, located at 17800 13th Street, Beale AFB, Yuba City, California 95992. Beale AFB would use this \$148 million to construct a MDOC on base. The MDOC is a two-story facility that would consolidate aircraft maintenance, training, and operational/mission planning for the high-altitude intelligence, surveillance, and reconnaissance mission and for new missions planned for Beale AFB. This is important because it allows Beale AFB to upgrade, expand, and modernize assets that would sustain and expand its mission and long-range strategy. Furthermore, the MDOC project was included in the Fiscal Year 2025 Unfunded Priority List for Air Force. It is a good use of taxpayer funds as funding for this project is critical to the continued operations of ISR assets at Beale AFB, as well as a critical foundation to sustain Beale's mission and long-range strategy. Construction of the MDOC improves U-2 operational efficiency, as well as supporting future ISR missions based out of Beale AFB by enhancing mission planning, integration with current ISR platforms, maintenance and flight line operations.

The federal nexus is 10 U.S.C. Chapter 169 and the project is authorized in the FY25 NDAA (P.L.118-159) under Title XXIII, Sec. 2301(a)
